- Institution must recruit 1 Professor before the commencement of the academic session.
- Adequate Infrastructure and cadre-wise qualified faculty as per COA Norms should be appointed/ maintained by the institution at all times.

The institution shall initiate immediate remedial action on the above deficiencies before commencement of academic session 2023-2024 and shall submit its compliance to the Council at the earliest.

The Council shall be at liberty to inspect the Institution at any point of time to assess the Minimum Standards of Architectural Education prescribed by the Council and to ascertain that the institution is imparting architectural course as per the Norms prescribed by the Council, from time to time. In case the institution is found to be imparting deficient education during 2023-2024, appropriate action shall be initiated against it.
